### 4. DATA RETENTION PERIOD

The Data will be processed for the entire duration of the subscription to the newsletter service, or - in any case - until withdrawal of consent (which can be requested at any time).

If the Data Subject does not confirm the subscription to the newsletter, his or her contact will be erased 2 months after the request.

## 5. DISCLOSURE OF DATA TO THIRD PARTIES - DATA RECIPIENTS

The Data will be processed by the Controller's employees and/or collaborators who received adequate operating instructions and were expressly authorised to the processing, as well as by third parties/companies that will perform technical, organisational and operational tasks on behalf of the Controller and in turn will be appointed Processors in accordance with Article 28 of the GDPR, e.g. IT service providers, marketing e-mail platform provider, companies in charge of managing our website.

The Data will not be disclosed or transferred to third countries (outside the EU) or international organisations.

### 6. RIGHTS OF THE DATA SUBJECTS

With regard to the provided Data, the GDPR (articles 12 and 15-22) grants that every Data Subject (natural person to whom the Data refer) can exercise the right to access the Data concerning him or her and the information about processing; to rectify or integrate the data if inaccurate or incomplete. Moreover, where the conditions set forth by the regulation are met, the Data Subject can exercise the right to erasure of the Data; to restriction of processing; to Data portability intended as the right to receive the data from the Controller in a structured, commonly used and machine-readable format in order to transmit those Data to another controller without hindrance. The Data Subject can also exercise the right to object to processing, and not to be subject to a decision based solely on automated processing. If the Personal Data processing is based on consent, the Data Subject has the right to withdraw his or her consent, without prejudice to the lawfulness of the processing performed before the withdrawal. Furthermore, if the Data Subject believes his or her rights have been harmed, he or she may lodge a complaint with the competent Authority for the protection of personal Data.
